RULES AND REGULATIONS

1. Tables and Chairs : All organizations and venders must supply their own tables and chairs.
2. Certificates of Insurance : All organizations and venders attending the planned function or event are required to be covered in the amount not less than \$1,000,000 per occurrence. Your insurance policy must establish the above listed minimum coverage requirements and show the Township of Stillwater as an additional insured party. The Township Committee may require "special event " insurance coverage if deemed appropriate. A copy of the required general liability and property damage insurance policies must be submitted with this application and prior to the event.
3. Parking : Parking is permitted in designated areas ONLY. There is no parking on the grass or on the driveways. Authorized Emergency Vehicles are the ONLY Exceptions.
4. Tent Space : Space under the tents/pavilion are for non - profit organizations and are on a first come, first serve basis.
5. Non - Profit : These organizations have first choice of booth activities based on the previous year participation or will be done on a first come, first serve basis.
6. Hours : Set up time will begin at 12:00 pm. Stillwater Day will run from 2:00 pm until dark with Fireworks ending the evening.
7. Clean - Up : All organizations / Venders are required to completely clean up their area before leaving and remove their garbage by 10:00 pm.
8. Prohibited Sales : There are no sales of silly string, stink bombs, poppers/pop rocks, ink or any other type of squirting liquid. The Recreation Commission reserves the right to approve/ disapprove any or all items to be displayed or offered for sale.
9. **ALCOHOLIC BEVERAGES ARE PROHIBITED, THERE WILL BE NO EXCEPTIONS**

The participant agrees to assume the entire responsibility and liability for all damages or injury to all persons, and to all property, arising out of or in any manner connected with Stillwater Township - Stillwater Day to be held on Saturday, June 17, 2017 and to the fullest extent permitted by law, the Participant shall defend and indemnify the Township of Stillwater and the Stillwater Township Recreation Commission from all such claims including without limitation claims for which the Township of Stillwater and the Stillwater Recreation Commission may be claimed to be liable by reason of its own independent negligence.
